



LITE Membership in the National Municipal Lawyers Association is Attainable, Desirable and Affordable

National IMLA is the only national organization devoted exclusively to local government law. National IMLA is the organization supporting the local government lawyer on primarily federal issues just as the Indiana Municipal Lawyers Association supports the local government lawyer on primarily state law issues. As the world gets smaller the need for membership in both organizations grows.

If you represent a municipality of 2500 in population or less and there is a membership in either the Indiana Association of Cities and Towns or the Indiana Municipal Lawyers Association then for \$50 you can take advantage of the LITE Membership Program of the National IMLA. *

National IMLA LITE is designed to allow smaller communities to become quasi-members of National IMLA at a reduced rate. The benefits of this quasi-membership include the National IMLA e-newsletters, the Municipal Lawyer magazine and the ability to register for a National IMLA program as a member. The bi-weekly e-newsletter sorts through case law and other developments around the country and summarizes local legal development on a timely basis. National IMLA also recruits legal experts to author in-depth articles published in its bi-monthly magazine, the *Municipal Lawyer*. National IMLA has an Annual Seminar and *Section 1983 Defense* Conference on April 20- April 23, 2018 in Washington, DC and has a conference in the fall. The 2017 Fall Annual Conference is in Niagara Falls, Ontario, Canada (10/14 – 10/18, 2017). A passport is required. National IMLA LITE Members have the ability to register for an IMLA program at the reduced member rate. The National IMLA seminars and conferences offer Indiana Continuing Legal Education Credits. Other stand alone seminars and teleconference educational sessions are also available.

National IMLA LITE members however will not get the printed model ordinance service or the right to vote or serve on the board; but will have access to the electronic version of the model ordinance service. Here is the link to the full National IMLA membership rates:
