



IMLA—A valuable Resource for City, County and Town Attorneys:

IMLA was formed in 1983

- ◆ to collect and disseminate information on matters of concern to attorneys practicing in the field of municipal law,
- ◆ to promote the continuing education of attorneys on issues affecting municipal law, and
- ◆ to provide forums for attorneys practicing municipal law to meet and exchange ideas and professional experience.

IMLA is a not-for-profit corporation that is also an affiliate of Aim, Accelerate Indiana Municipalities, which provides contracted services to IMLA.

IMLA publishes newsletters and electronic notices during the year that highlights recent changes in the law, both legislatively and case law.

IMLA can create a listing of its members so that member attorneys may receive information about others they may call upon as a resource.

IMLA holds the **Municipal Law Seminar** each year **tentatively set for a June 21-22, 2018** at the **NEW Embassy Suites in Noblesville at I 69 North exit 210** for **9 CLE** credits. It also participates each fall in the **Aim Ideas Summit**, an annual conference with CLE credits. Next year the **Ideas Summit will be in French Lick, Indiana (October 2-4, 2018)**. IMLA contracts with Aim to bring its members continuing legal educational opportunities through qualifying workshops as part of the Aim local officials' education programs. IMLA membership provides you advance notice, reduced attendance rates and handles all of the CLE attendance reporting for qualifying sessions. Some Aim Webinars qualify for CLE Distant Learning credits if requested. Contact Jodie Woods for CLE needs.

IMLA is open to county attorney membership. The County Attorneys also have required representation on the IMLA Board of Directors. Ronald Cross of Wayne County, IMLA Vice President, and Robert Clutter of Boone County, Immediate President, represent county attorneys on the IMLA Board.

IMLA members are automatically placed on an IMLA attorneys-only list serve upon the processing of annual IMLA dues for the calendar year (opt out required). IMLA members may also participate in the Aim discussion list serve.
