ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

• Fill in for Supervisor when he is not available

- Pulls samples in plant, well field and distribution system. Samples include IOC's, VOC's and SOC's, fluoride, bacteria, nitrate, copper, lead and sodium.
- Change WTP flows to accommodate seasonal usage with higher flows in summer and lower flows in winter.
- Handle some customer issues regarding water quality.
- Attend meetings and trainings as necessary
- Ensures all policies and procedures are implemented appropriately.
- Lead the crew on projects as designated and assure that activities are completed safely, accurately, and efficiently.
- Lead the crew in a safe manner while reflecting compliance to department policies and training each crew member as needed.
