The City of Auburn Water Pollution Control Department is seeking a hard-working, self-motivated individual to join our team as a full time Plant Maintenance Technician. This position primarily assists with wastewater treatment plant maintenance duties, troubleshooting and/or problem solving, preventative, predictive and corrective maintenance services and support for the WPC plants, lift stations and all other related appurtenances. The ideal candidate should have a strong work ethic, a background in mechanical maintenance, excellent problem solving skills, ability to perform basic mathematical equations, be motivated to serve others, and enjoy working in a fast-paced environment.

Essential Duties/Skills/Responsibilities/Qualifications

- Ability to assemble, install, maintain, calibrate, troubleshoot and repair and/or replace electrical, electronic, mechanical, pneumatic, hydraulic, digital and analog control equipment and systems.
- Operate, maintain, calibrate and repair pneumatic and electronic testing and measuring instruments.
- Maintain records and prepare reports on maintenance and repair work, calibration readings and related data.
- Order parts, supplies and equipment.
- Read and interpret schematic diagrams, blueprints, sketches and equipment specifications.
- Perform mathematical calculations related to the trade.
- Have a working knowledge of Supervisory Control and Data Acquisition (SCADA) Systems for General Wastewater Treatment Operations Monitoring and Controls, and Wet Weather Flow Monitoring and Controls.
- Clean and maintain shop areas.
- Inspects, operates, adjusts, and calibrates equipment, as necessary.
- Performs Permit Required Confined Space Entries, when needed.
- Maintains up-to-date and accurate records and logs of operating conditions of equipment, weather conditions and on-going maintenance work being performed within the treatment plant.
- Assists other WPC divisions during emergencies or as requested by the Department Head.
- Maintains department buildings, structures and general facility grounds.
- Follows all City of Auburn policies and procedures in addition to all local, state, and federal standards, regulations, and safety rules.
- Learn and understand related regulations and standards for General Wastewater Treatment Operations Monitoring and Controls and Wet Weather Flow Monitoring and Controls. This may include certification or additional training courses.
- High School diploma or equivalent.
- Possess a Valid Driver's License with acceptable driving.
- Requires working some evenings and/or weekends, primarily outdoors in all types of weather conditions. Requires working in and around water and sewage, often dirty and offensive odors.
