June 6-10 ILMCT 84th Annual Conference and State Board of Accounts School

Our annual conference will take place in Evansville, Indiana. The League will conduct its annual business meeting during the conference as well as the election and installment of officers. Aim will offer a day of education on Monday, June 6. The State Board of Accounts School is a two-day state called meeting on June 8 and 9. In addition to the State Board of Accounts, representatives from the Department of Local Government Finance, Indiana Department of Revenue, the Internal Revenue Service, the Indiana Public Retirement System and other agencies are invited to provide updates. There will be an exhibit hall for connecting with vendors as well.

Regional Meeting in October 2021

The League holds a two-day event. One day is dedicated to the ILMCT Institute and Academy and the second day is a State Board of Accounts state called meeting.
