While cities have long dealt with major public safety events such as rallies, demonstrations, protests of all kinds, as well as angry and unpredictable citizens, our polarized public discourse has presented increased challenges. The void of online civility has become somewhat commonplace, leaving many numb to the way we address our neighbors with different opinions, as well as other contrasts. This comfort level has left many emboldened to espouse extreme views in public settings, sometimes creating unsafe situations. Experts from the Indiana State Police will be on-hand to offer detailed advice for local officials in their handling of the growing extremes in Hoosier cities. Mayors will also be invited to ask questions about specific circumstances and offer first-hand accounts of how fringe views have impacted their communities.
