9:30 a.m. – 10:30 a.m. **WORKSHOP:** Indiana’s Rural Economy in the 21st Century

The first detailed examination of rural Indiana this century reveals a number of interesting and unexpected findings. The comparisons of numerous factors highlight the stark differences between rural and urban communities. In addition, the definitions of rural and urban places are changing and this contributes to the perception of incessant rural decline. This presentation will also discuss the movement of people, through commuting, immigration and migration, and what this means to rural Indiana. A strength of rural Indiana is the connection with urban places, but rural communities can still suffer from lower government service quality, too little human capital focused investment, and heavy reliance on economic policies that do not yield growth. We’ll conclude with four broad areas of policy intervention for federal, state and local policymakers, along with advice for private sector participants.
