

WORKSHOPS

TUESDAY, AUGUST 9

1:30 p.m. – 2:30 p.m. Impact of Solar in Indiana

The Indiana Municipal Power Agency (IMPA) has been working towards adding over 40 solar parks throughout Indiana. IMPA will discuss these efforts along with their involvement in solar purchase power agreements. The workshop won't conclude until the benefits, limitations, cost, and supply chain challenges of solar are reviewed.

The Role of Women in Making Relocation Decisions

Join us as Amanda Weinstein and Michael Hicks present recent research on quality of life. Dr. Weinstein examines the role of gender in household location choice and preferences for amenities in metropolitan areas in the United States. This work lends crucial insight into the decision-making process as families consider municipalities around Indiana. Dr. Hicks provides an analysis of the American Legislative Exchange Council's "Rich States, Poor States" rankings, evaluating ALEC rankings growth predictions against alternative explanations for regional economic growth. These rankings have dominated policy choices in Indiana since they were first published in 2007.

9:30 a.m. – 10:30 a.m. Future of Policing Task Force -Bloomington

All Indiana cities are struggling with various aspects of public safety hiring, retention, and execution. In Bloomington, they undertook a year long process of reviewing law enforcement in the city, resulting in recommendations in the areas of salaries, community policing, intercultural and interpersonal communications, staffing levels, and much more. This workshop will review Bloomington's work and discuss any elements other Hoosier municipalities can use address their own law enforcement challenges.

10:45 a.m. – 11:45 a.m. Lead Service Line Project Development Process

The presentation will address a Lead Service Line Replacement (LSLR) program's approach to working on the public and private sides of the water services. The development of the program will be discussed, detailing the bidding approach, customer notifications/interaction, water service installation, site restoration and commissioning/testing. Specifically highlighting methods used to successfully address individual customer concerns related to private property access and performing work in residential basements.

This presentation is focused on the current state of the utility industry with respect to qualified operators. Utilities are taken for granted in most instances as they provide reliable service that is depended on daily by everyone. However, due to an aging workforce and reduced interest in this field as a career, the utility industry faces a significant challenge and may pose risk to communities if this is not addressed.

Avoiding and Responding to Lawsuits Public entities are more prone to litigation when compared to other business operations. In this workshop we will discuss the reasons for the number of lawsuits and their true cost, and measures you can take to mitigate their



impact. We are all aware of the costs incurred by lawsuits but there are other costs that must be calculated. The expanded use of social media platforms is something additional that you should be careful with and become cognizant of the potential for lawsuits from their use.

Build-Operate-Transfer (BOT) Statute The Indiana Build-Operate-Transfer Statute has been largely used for social infrastructure such as parking assets, courthouses and justice centers, police and fire stations, and similar government facilities. On July 1, 2022, the law changed to expand the applicability of this project delivery method to specifically include authority for local governments to use it for roads, bridges, tunnels, and other transportation infrastructure investments. This session will outline the additional tools under the statute and will discuss creative approaches can facilitate horizontal infrastructure investment.

Residential Tax Increment Finance

Realtor data across our State conveys a consistent message - we have a housing shortage in Indiana. The State addressed this shortage through a program allowing Redevelopment Commissions to capture 1% residential property. In this presentation, we will dive into the ways our municipalities can capture residential 1% assessment growth and subsequently use this growth to incentive housing development projects.
