WORKSHOPS

SEA 1 and Beyond: Navigating the Latest Legislative Changes for Indiana Municipal Officials

Join members from the Aim legislative team for an interactive discussion focused on Senate Enrolled Act 1 (SEA 1) and its implications for local government operations. This session will provide actionable insights into the next steps required for compliance and implementation of SEA 1. In addition to SEA 1, the workshop will provide an overview of key legislative matters leading into the 2026 session.

Navigating Change: Strategies for Local Government Success in a Shifting Legislative Landscape

As local governments face increasing fiscal pressures and shifting legislative impacts, innovative approaches are becoming vital. This session will explore how municipalities can successfully plan, fund, and deliver essential public services amid the evolving challenges posed by SEA 1. Participants will learn how regional collaboration and public-private partnerships (PPPs) are being used effectively to stretch limited resources, attract investment, and sustain critical community services.

Navigating the Indiana Department of Transportation: Partnerships, Projects, and Responsibilities in Local Infrastructure

Successful local infrastructure projects require strong coordination between municipalities and the Indiana Department of Transportation (INDOT). This workshop is designed to gain a clearer understanding of how to work effectively with INDOT on transportation projects, utility coordination, and funding opportunities. Topics will include how to access and leverage INDOT's matching assistance programs, clarify responsibilities related to roads, sidewalks, utilities, and right-of-way issues, and build on productive relationships with INDOT.

First Amendment in Action: Guidance for Municipal Leaders

Indiana municipalities are navigating new terrain following a recent First Amendment decision. This session will explore what is legally permissible when managing public comments on government social media posts and during municipal meetings, providing practical strategies to balance transparency, community engagement, and compliance in today's digital and public forums.

Talk of the Municipalities: A Roundtable Discussion on Collaboration and Community Partnerships

Municipal managers are increasingly expected to collaborate beyond their own community. This session will bring attendees together to share experiences, explore challenges, and highlight innovative approaches to partnering with school districts, nonprofits, and private-sector organizations to better serve the needs of their communities.
