10:45 a.m. – 11:30 a.m. **Mayors’ Idea Exchange: AI at the City Level: Enhancing Infrastructure, Services and Community Engagement**

Mayors Scott Mentzer and Dan Rickord are taking a practical, results-driven approach to artificial intelligence in local government, focusing on real-world applications rather than buzzwords. The cities are leveraging AI-powered roadway analysis through Vialytics to proactively identify issues and prioritize street maintenance based on data. They are also integrating resident reporting through SeeClickFix to ensure community concerns directly inform operational decisions. To strengthen organizational continuity, the City Decatur uses Ordinal to centralize knowledge and ensure all team members have access to consistent, reliable information. Attendees will gain a behind-the-scenes glimpse into Ordinal’s functionality. Together, these efforts demonstrate how AI can enhance service delivery, improve infrastructure management, and preserve institutional knowledge.

**Workshop:** Strengthening Ties to Local Foundations and Philanthropic Organizations Offers Unique Opportunities Around Indiana
